Swimming Information:

Locker rooms will be open for changing from street clothes to swimming attire—please, no loitering. When not competing, swimmers will stay in the auditorium across the hallway from the pool—bleachers are reserved for spectators. Only swimmers competing in the event will be allowed in the starting block area.

A ten-minute break will be held following the Butterfly and Breaststroke events—the pool will be open for warm-ups during the breaks.

It will be the responsibility of swimmers and coaches to be at the starting block for their events. To assist in tracking the meet schedule, events will be announced in the pool and auditorium, and video of the scoreboard will be displayed in the auditorium and cafeteria (concession area).

Spectator doors will open at 9:15AM .

ENTRY INFORMATION

1. All entries must be received by District Meet Manager, Gary Layne, by **Noon on Sunday, February 7, 2010**. All entries must be submitted in Hy-Tek format. Event files are available at: <http://www.ohsaa.org/sports/sd/entryforms/entry.htm> . Follow the instructions on the OHSAA web site (www.ohsaa.org).
2. All swimmers and divers must be on the eligibility sheet to be entered in the swimming and diving tournament. School Information Forms and OHSAA Eligibility Certificates listing all contestants are due to the District Meet Manager, Gary Layne, by **Monday, January 18, 2010**.
3. Entry times must be indicated for the events. No changes can be made in these times after the entry deadline.
4. Guidelines for entry to the Sectional/District tournament:
 - a. All contestants must be listed and properly entered on the original entry file. Their names must also appear on the eligibility sheet.
 - b. A team may have up to four (4) swimmers participate in an individual event.
 - c. A team may have only one (1) entry in each relay event.

- d. A contestant may participate in a maximum of four (4) events, no more than two (2) of which may be individual events. Being designated as a member of a relay does not count as an event until they actually swim the relay.
 - e. Each sectional will automatically qualify one (1) Division 1 boy and girl and one (1) Division II boy and girl per event/relay. The remainder of the field of thirty-two (32) individual qualifiers and twenty-four (24) relay teams advancing to Districts will be at-large. An automatic qualifier will not bump anyone who qualifies in the top 32.
 - f. Diving will be at-large with the top 32 eleven-dive scores from the sectional meets advancing to the District meet.
5. Replacing an individual after the February 7, 2010 entry deadline for the Sectional tournament requires a written excuse from a Medical Doctor. A swimmer may be replaced only; the line up cannot be changed.
 6. The championship format will be followed for the diving meet.
